The site is well-appointed and features a two-bay truck offload pad, a 3,300-barrel (138,000 gallon) tank farm with concrete secondary containment that is heated for winter conditions, desander and micron filtration, and two-2,000 BPD, 1,500 PSI triplex pumps.
